

**A RESOLUTION OF THE REPUBLICAN PARTY OF ARKANSAS, SECOND
CONGRESSIONAL DISTRICT CONVENTION, SUPPORTING FREEDOM FROM ANY
MANDATES ISSUED BY INTERNATIONAL ORGANIZATION TREATIES WITH THE
UNITED STATES OF AMERICA**

WHEREAS, Global organization such as the World Health Organization (“WHO”) and World Economic Forum (“WEF”) have no authority to subvert the Constitution of the United States and the Constitution of the State of Arkansas; and

WHEREAS, Within the Constitution of the United States, its 4th Amendment, and Article 2, Section 2 of the Arkansas State Constitution provides that all citizens of the state of Arkansas with inalienable rights, “amongst which are those of enjoying and defending life and liberty; of acquiring, possessing and protecting property, and reputation, and of pursuing their own happiness”; and

WHEREAS, There is a possibility that the current United States Executive Branch is considering entering into a ‘pandemic treaty’ with global organizations such as the WHO, United Nations, and the WEF, that may breach the sovereignty of the United States of America and the state of Arkansas; and

WHEREAS, During the COVID-19 Pandemic, the United States Executive Branch and the Executive Branch of the state of Arkansas made decisions that were viewed in conflict with the right of citizens to retain their freedom of choice for their individual health decisions to include the federal government as an employer mandating COVID vaccinations that did not complete the required trials as other vaccinations are required to endure before use on humans; nor were the COVID vaccinations proven to be effective in preventing the contracting or spreading of the virus; nor were masks and lockdowns proven to be efficacious in preventing the contracting and spreading of the virus; and

WHEREAS, During the COVID-19 Pandemic, primary and secondary schools, colleges and universities, as well as businesses were required to close their doors, resulting in the loss of education at all levels of achievement; the loss of social interaction between children, teenagers, and adults resulting in depression and, in some cases, suicide; the loss of income and forfeiture of small businesses, which is a violation of Arkansans rights to pursue happiness, and acquire, possess, and protect property;

**NOW, THEREFORE, BE IT RESOLVED BY THE ARKANSAS REPUBLICAN PARTY,
SECOND CONGRESSIONAL DISTRICT CONVENTION, THAT**

Section 1: The citizens of Arkansas have the right to be free from any jurisdiction exercised by any international organization. The World Health Organization, United Nations, and the World Economic Forum, shall have no jurisdiction or power within the State of Arkansas;

Section 2: No rule, regulation, fee, tax, policy, or mandate of any kind of the WHO, United Nations, and the WEF shall be enforced or implemented by the State of Arkansas or any state agency, department, board, commission, political subdivision, governmental entity of the state, county, municipality, or any other political entity;

BE IT FURTHER RESOLVED, that the Republican Party of Arkansas Second Congressional District Convention Chairman expeditiously and in writing, advise the elected officials who are potentially to vote and rule on this matter in the State of Arkansas of this Resolution.
